

CENTURIA VILLAGE BOARD MINUTES
June 8, 2015

The Village Board meeting was called to order at 7:30 by President Markert, with Tom Boettcher absent. Stan Swiontek made the motion, seconded by Gene Ludack, to approve the agenda. Motion carried.
