

**CENTURIA VILLAGE BOARD MINUTES**  
**June 13, 2016**

The Village Board meeting was called to order at 7:30 by President Markert, with everyone present. Kevin Kamish made the motion, seconded by Katie Peterson, to approve the agenda. Motion carried.

The motion was made by Rod Peterson, seconded by Gordie Moore, to approve the minutes from the May 9th board meeting. Motion carried.

The treasurer's report was approved showing a balance of \$255,013.20 for the month of May. The receipts were \$12,126.50 and the disbursements were \$100,936.64. The TIF balance is negative \$449,318.94.

Representatives from Fristad Lutheran Church were present to ask for the village's approval for them to have a Farmer's Market on Fridays in the Church parking lot from 5:00 pm to 7:00 pm.
