The Village Board meeting was called to order at 7:30 by President Rod Peterson, with everyone present. Stan Swiontek made the motion, seconded by Steve Sylvester, to approve the agenda. Upon voice vote, the motion carried.

The treasurer's report was approved showing a balance of \$506,894.78 for the month of May. The receipts were \$7866.59 and the disbursements were \$35,526.47. Pastor Duane Gallentine from the Grace Berean Church at 419 4th Street, said that the elders of the church had met and because of the proximity of the church, wanted to express no objection for the sale of alcohol. Jessica and Ricardo will turn in applications for the combined alcohol license and an Agent license and applications for any operators they plan to have working.

Stan also brought the request for the Water Utility to use a CD that had been the Electric Utility's and is now General Fund for maintenance imporvements.
